IGP Wines

It possesses a certain quality, reputation or other specific characteristics attributable to its geographical origin. At least 85% of the grapes must come exclusively from the geographical area. Its production must take place in the geographical area. Distillation is obtained from grape varieties belonging to *Vitis vinifera* and other types of the *Vitis* grape. Regulation (EC) 1234/2008 DOUE L 334, 12/12/2008, p. 7

Country Wines - CW (Vinos de la Tierra - VT)

These products come from certain areas of Spain where a perfectly identifiable wine is made with definite local characteristics, in compliance with vinicultural and oenological standards.
