

LEGAL TERMS AND CONDITIONS

For the purposes of these Terms and Conditions, "The Promoter" refers to ICEX ESPAÑA EXPORTACIÓN E INVERSIONES, E.P.E. whose Instagram handle is @spainfoodwine and Facebook page @Foods & Wines From Spain US . The "Prize" refers to five wine.com \$150 gift cards.

By entering the giveaway you agree to be bound by these terms and conditions. All entries must be received from 11/03/2023 until 13/15/2023. Five (5) winners in United States will be selected at random by The Promoter on 16/10/2023 and the winner will be notified on or after this date.
